7. EMERGENCY PROCEDURES:

If in Eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Seek medical attention.

If on Skin or Clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. If irritation persists, seek medical attention. Call a poison control center or doctor for treatment advice. Have the product container or label with you when calling a poison control center or doctor, or going for treatment. NOTE TO PHYSICIAN: There is no specific antidote for Atrazine. If this product is ingested, induce emesis or lavage stomach. The use of an aqueous slurry of activated charcoal may be considered.
