**4. FIRST AID MEASURES**

Eye contact	Hold eyes open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for further treatment advice.
Skin contact	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**6. ACCIDENTAL RELEASE MEASURES**

**Chronic effects**

<b>Chronic Toxicity</b>	Repeated or prolonged exposure may cause central nervous system effects.
<b>Carcinogenicity</b>	Bifenthrin: Not recognized as carcinogenic by Research Agencies (IARC, NTP, OSHA, ACGIH). Did not show carcinogenic effects in animal experiments.
<b>Mutagenicity</b>	Bifenthrin: Not genotoxic in animal studies
<b>Neurological Effects</b>	Tremors were associated with chronic exposure of laboratory animals to bifenthrin, which may disappear with continued exposure
<b>Developmental Toxicity</b>	Bifenthrin: Not teratogenic in animal studies.

**Target Organ Effects** Bifenthrin: A slight increase in male mouse urinary bladder tumors at the highest dose was probably not of toxicological concern.

**Chronic Toxicity - Other Ingredient(s)** Repeated overexposure to propylene glycol can produce central nervous system depression, hemolysis and minimal kidney damage.
